#### Effect on Cure Speed of Cyanoacrylate Adhesives

Fixture time and cure speed achieved as a result of using  $\text{LOCTITE}^{\textcircled{B}}$  SF 7452 depend on the adhesive used and the substrate bonded. The fixture time is defined as the time to develop a shear strength of 0.1 N/mm<sup>2</sup>.

**Directions for use** 

#### Post Activation

- 1. Apply LOCTITE<sup>®</sup> cyanoacrylate to the parts to be bonded or fixed.
- Apply activator over all exposed cyanoacrylate adhesive by spray or drop. (Typically use one drop of activator per drop of exposed adhesive).

#### **Surface Activation**

- 1. Apply one coating of activator to the area to be bonded by spray, brush or dipping. Contaminated surfaces may need special cleaning or degreasing prior to activation to remove any soluble contamination.
- 2. Allow LOCTITE<sup>®</sup> SF 7452 to fully evaporate from parts prior to bonding to avoid solvent entrapment within the bond joint.
- 3. Apply the LOCTITE<sup>®</sup> cyanoacrylate product immediately after drying.
- 4. Activator can be re-applied if necessary if there is a delay between original activator and adhesive application.
